## B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

This corner established in Isabella County Remonumentation Program. See dossier for detailed report.

This is an existent corner.

1. Found capped iron

2. Found 3/4" pipe around capped iron

3. Found stove iron under and around found pipe

4. Found pottery shards under and around found pipe

5. Found remnants of old stake in the form of severely discolored soil in a localized area

6. Excavated to 4'. Found no further evidence.

Accepted as the best available evidence of the position of the original corner and replaced with Standard Monument Corner.
