Part A: Corner(s) History

- G13 & G1** – 1830 – GLO – R. Clark, Jr. – Set Post
- 1) Pine 10" N46°E 19 L.
  - 2) Pine 8" N54°W 7 L.
- 1852 – GLO Subdivision T15N, R1W – A. Burt
- S0°46'W Corr. between Sec. 3 & 4
  - 3) W. Pine 12" S22°E 35 L.
  - 4) W. Pine 10" N33°W 27 L.

Part B: Surveyor’s Report on Perpetuation or Monumentation of Corner(s)

**G13 & G1** – Standard Corner common to Section 33 & 34, T16N, R1W and Section 3 & 4, T15N, R1W – No GLO evidence found. Searched for line trees east and west but nothing conclusive found. Set stamped 4” DNR Aluminum cap on 1” x 36” galvanized iron pipe by single proportion on the line of parallel between ‘C1 – C13’ and ‘I1 – I13’. Centerline of E-W gravel road is 47’ south. DNR monument accepted as a careful and faithful re-establishment of the position of the original corner.

**G13 & G1** - Stamped 4” DNR Aluminum cap on 1” x 36” galvanized iron pipe.  
Set blue composite post 1’ north.

S40°W 24.94’ to set nail & tag in west side 28” White Pine scribed ‘XBT’  
N47°E 36.77’ to set nail & tag SE side 12” White Pine scribed “XBT’
