- 1) Aspen 9" N57°W 32 L.
- 2) Aspen 4" S35°E 10 L.

Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

D13 & D1 – Standard ¼ corner common to Sec. 32, T16N, R1W & Sec. 5, T15N, R1W – No GLO evidence found. No evidence of any monument found. Set DNR Monument by single proportion to GLO between 'C13 – C1' and "I13-I1" on the parallel of latitude. N-S single strand is 50.5' West. Centerline of E-W Ditch is 9.5' North. DNR Monument accepted as a careful and faithful reestablishment of the position of the original corner.
