## Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

C8 – ¼ Corner common to Section 19 and 20, T16N, R1W – Found remains of witnesses #3 & #5, dug 2' x 3' area, wet sand but no conclusive evidence of wood post was found. Set stamped 4" DNR aluminum cap on 1" x 36" galvanized pipe from the pine stump BT's. Also fits GLO White Pine Line Tree stump to the south. S0°40'05"W 601.22' (Grid) [603.24'- 20" W. Pine – GLO] to set 2" Alum. Cap on 5/8" x 34" rebar in centerline remains 20" WPS. DNR Monument accepted as a careful and faithful perpetuation of the position of the original corner.
