Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

B11 – ¼ Corner common to Section 30 & 31, T16N, R1W – No GLO evidence found. Found remains of Gibbs' witnesses #5 & 6. Excavated for evidence of Gibbs' position but was apparently obliterated by construction of old E-W road bed. Thus set DNR Monument from Gibbs' BT's. Centerline of E-W 2-track is 4'± South. DNR Monument accepted as a careful and faithful reestablishment of the position of the original corner.

PCC Near 'B11' – S65°12'E 3.14' from ' B11' found ¾" iron pipe with Cap #19838 per Jones and used by Burgin. ¾" CIP doesn't agree with Gibb's BT's and is not utilized as 'B11' in this survey. This property controlling corner is recorded by this surveyor strictly to comply with the requirements of PA 74 of 1970 as amended and P.A. 345 of 1990 as amended and is not an endorsement of the corner position.
