#### Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

<u>B10</u> – C ¼ corner Sec. 30, T16N, R1W – Found pointed cedar post bottom 3" dia x 1' long under 2'± of water in beaver pond flooding- vertical down in the clay muck. Set 5/8" x 5' long rebar in place of post point to tie. Fits intersection of ¼ lines very closely and Gibb's survey dimensions N, S, E & W closely. West 30' to bottom bank and edge of beaver pond. Cedar post point accepted as the best available evidence of the position of the corner per the Gibb's survey.
