#### Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

<u>B9</u> - ¼ Corner common to Section 19 & 30, T16N, R1W - Fd. ½" iron rebar - 2'± North of centerline old E-W road bed through swamp. This iron is at record GLO distance East of 'A9'. Remains of old down barb wire fence S is 4'± West. A newer fence to the north - ½ standing and ½ on ground is basically in-line with iron. Excavated 10'± E-W by 6-8' N-S area in road bed from iron west searching for evidence of wood post but nothing vertical was found. No GLO or CSR evidence was found. A single proportional position using the record 1852 GLO angle would be S43°29'W 3.04' of this position. Accepted ½" rebar as the best available evidence of the position of the original corner.
