**Part B: Surveyor's Report on Perpetuation, Restoration, Reestablishment, or Monumentation of Corner**

5 – CN 1/16 Corner Sec. 30, T16N, R1W – Could not find any conclusive evidence of Gibb's gas pipe or witnesses. Excavated along 10' of E-W Fence searching for pipe but must have been removed during construction of fence. Fence is old barb wire on ground and newer wolver wire still standing. Thus set stamped 2" Aluminum Cap on 5/8" x 34" long iron rebar per Standard BLM procedure. Falls in said E-W fence. Found trace of fence to the North in 24" WPS 67' North.

6 – NE 1/16 Corner Sec. 30, T16N, R1W – No evidence of monument. Set 2" Alum. Cap on 5/8" x 34" rebar per standard BLM procedure. Corner of wolver wire fence W & S is 2.5'± N & 9'± E. Corner falls on E. side of elevated deer blind.

**Part C: Field Evidence of Perpetuation or Monumentation of Corner**

5 – CN 1/16 corner Sec. 30, T16N, R1W – Stamped 2" Aluminum Cap on 5/8" x 34" long iron rebar. Set Blue Composite Post with loc. tag 1' N. N57°E 11.29' to set N & T in N. side 7' W. Oak N19°E 41.34' to set N & T in W. side 13" Red Maple N36°W 60.44' to set N & T in SW side 12" Red Maple. N78°W 55.01' to set N & T in N. side Tw. 17" & 26" Oak.

6 – NE 1/16 Corner Sec. 30, T16N, R1W – Stamped 2" Aluminum cap on 5/8" x 34" long iron rebar. Set Blue Composite Post with loc. tag 1' NE N87°E 6.09' to set N & T in S. side 15" Oak N46°E 25.45' to set N & T in NW side 9" R. Maple N03°W 18.42' to set N & T in S. side 7" R. Maple S65°W 46.97' to set N & T in N. side 8" Oak
