M-11 Corner common to Sections 25 and 36 on East townline

Found 3/4" pipe in monument box at position per surveys by F. Gibbs, MDOT, M. Hunter, J. Jones and LCRC by E. Goss and P. Lapham.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

M-11 Corner common to Sections 25 and 36 on East townline

Replaced pipe with 5/8" rod and brass cap stamped Midland Co. Remon Cor. PS 29241 and is accepted as the best available evidence of the position of the original corner.

N 80 Deg E, 21.65', pk nail in top guardrail post  
N 25 Deg E, 74.41', chiseled "+" in East end of Southeast wingwall  
N 20 Deg W, 70.90', chiseled "+" in West end of Southwest wingwall  
N 50 Deg W, 64.16', nail in post  
S 55 Deg W, 107.10', nail and MDOT disk in 18" Cottonwood  
North 2.11', Edenville Twp. corner A-11  
(GLO calls for 3 links jog 1.98 ft.)

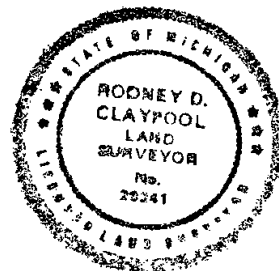
