Description of original monument and accessories and/or subsequent restoration: K-5, 185, R/E, 1/4 Section Corner Common to Sections 11, 12, 13 & 14

(Erie and Crabb Roads - 3 inch asphalt, 8 inch large stone & gravel, yellow sand) 1820, G.L.O. Surveyor, Joseph Wampler, set post at corner of Sections 11, 12, 13 & 14 and witnessed: B. Oak 19 inch N.40°E. 14 links & B. Oak 21 inch S.84°W. 34 links. Approximately mid 1900's, I.P. shown in old survey books. 1952, M.R. Fleck show R.R. spike. 1953, M.C.R.C. witness card shows fd. I. bar. 1970, A.J. Marino notes F.I. at CL exist. pv't. 1973, Case & Fleck witness card shows iron rod. 1973, G.B. Warnke surveys recorded in Liber 654, Page 850 & Liber 654, Page 849 & Liber 654, Page 845, to fd. I. pin. 1973, Frank R. Moskos records L.C.R.C., Liber 1, Page 378, to found iron. 1990, G.B. Warnke records L.C.R.C., Liber 3, Page 131, to 1/2 inch rebar.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

K-5-8/1994, Found 1/2 inch x 18 inches long iron rod at surface. Dug 18 inch x 30 inch hole, probed, no stone or post found. Set 1 inch x 36 inch iron pipe inside monument box to replace rod and witnesses as shown below. 11/11/1994, set brass remonumentation cap on 1 inch x 36 inch iron pipe.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

K-5 - Set 1 inch x 36 inch iron pipe with brass remonumentation cap inside monument box to replace 1/2 inch iron rod and is accepted as the best available evidence of the position of the original corner and Witnesses:

North 45° West 45.00 feet to found nail & coin southeast side electric pole

North 40° East 63.56 feet to found nail & shiner southeast side telephone pole

South 45° Fast 45.94 feet to found nail & coin northwest side telephone pole

South 50° West 48.50 feet to found nail & coin east side guy pole
