Description of original monument and accessories and/or subsequent restoration: I-5: Section Corner common to Sections 10, 11, 14, and 15.

1845: Sam U. Hill's original subdivision survey notes describe the corner monument as a wood post referenced by:

1990: An LCRC recorded by Alan K. Pierce P.S. #30097 in L. 5, RC Pg. 285, indicates no original corner evidence recovered. He found an apparent wood cruiser's post with 3 blazed trees facing post, but rejected the post as evidence of the corner location. Pierce established the corner by use of original government terrain calls in conjunction with old C.C.I.C. coordinate values that preceded flooding of the McClure Storage Basin. Found wood post bears approximately N62W, 124' from corner location. The following measurements were obtained to G.L.O. record feature calls: "Summit of Knob" (indistinct and 20' +/- wide) -North 1188' (GLO) 1140' (ECI); "Ravine" - East 655' (GLO) 652' (ECI); "Summit of Ridge" - East 794' (GLO) 768' (ECI); "Ravine" - East 1388' (GLO) 1408' (ECI); "Summit of Knob" (no knob found) - South 4158' (GLO) 4148' (ECI); "Ravine" (not pronounced, gradual) -South 4620' (GLO) 4665' (ECI); "Summit of Knob" (indistinct - no knob found) - South 5082' (GLO) 5102' (ECI); "Summit of Knob" - West 1452' (GLO) 1440' (ECI); "2 L. Stream" - West 1745' (GLO) 1749' (ECI); "Ravine" - West 3762' (GLO) 3715' (ECI); "Summit of Ridge" - West 4620' (GLO) 4770' (ECI). Pierce set a 1/2' X 2' capped rebar with a concrete collar at the calculated best fit position supported by old coordinate calculations. Corner is located near the summit of extensive wooded rock outcrop. Referenced by P.K. nails in orange plastic washers stamped "ECI-30097" in the side of bearing objects. Bearing trees were face, nail, and butt blazed, painted yellow, with butt blazes scribed "BT": Referenced by: 10" Oak N55E, 20.91

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I-5: 1998: Searched and found no evidence of original B.T.'s. Found and accepted a 1/2" rerod and ECI cap #30097 as described in L. RC Pg. 285. Bearings as distances to recorded references check very well. Checked Line Call: (Ravine, 9.93 chains [655.38'] East from corner). Measured Call: East, 600' to Eastern side of Ravine. Distance West is 2682.72', and Distance South is 5322.68'.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

I-5: 1998: Replaced found cap and iron with a 2 3/8" O.D. aluminum pipe capped with a 3 1/4" diameter aluminum tablet Marquette County Survey Monument stamped to identify the corner. Measured existing references after painting blazes. Replaced P.K. nails and washers with d.h. nails:

1990: A Certificate of Survey recorded by Alan K. Pierce P.S. #30097 in L. 001, SM Pg. 656, indicates the corner as described above in L.5 RC, Pg. 285. Distance S89-32'-03"W, 2682.88' to a set concrete monument at the North Quarter Corner of Section 15. Distance S00-35'-32"E, 5322.96' to a found brass capped pipe at the S.E. Corner of Section 15. No accessories given.

In a conversation with Al Pierce, P.S. on October 13, 1998 he indicated that the GLO line calls he checked were generally not as definite on the ground as described in the GLO notes. He ran a random line North of the corner area on an extension of the East line of Section 15 from the S.E. corner of Section 15 thru the prorated East-West GLO line calls. This line was used to locate the Summit of Knob North (1188' GLO). He did not go to the 1/4 corner to the North (I-4). He also indicated that because of the indistinct nature of the GLO line calls, he used a best fit average location of the North South calls to position the corner. The GLO call to the Stream West fit well with the ridge and ravine calls to the East and were used for corner placement East and West.
