Set post. 9" S55W 12 links, Spruce 10" S86E 42 links. July 17, 1947 notes in F.B.601, p.125 Marquette Co. Road Commission state "A squared and dry J.Pine marked app. 1/4 cor. Found no BT's. JJH" Found no subsequent record.

(4-Sec. 16) Northwest 1/16 corner, Section 16. Not previously monumented.

- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- (F7) The original post and accessories were not recovered. Did not find the dry J. Pine noted in the Rd. Commission notes. Found no acceptable evidence of the position of the original corner on the Reestablished the position for the corner midway and on the Section line between Section ground. corners 2644.86' east and west, being proportionate to the original record.
