

- B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
- 4 ~ NW 1/16 Corner Sec. 11, T23N, R5W Dug 3' x 4'± area from possible remains of witness #1. No evidence of stake remains were found. Thus set 2" Alum. Cap on 5/8" x 34" rebar per Standard BLM procedure. The excavated area was N47°W 10'±
- 9 CE 1/16 Corner Sec. 11, T23N, R5W No evidence of cedar post was found. Area disturbed by road and pipeline construction in past. Set 2" Alum. Cap on 5/8" x 34" rebar per standard BLM procedure. NNW 24' to centerline of 2-track ENE. A ½" iron pipe was found S67°37"W 39.75' in line with 10' high deer fence that goes SSW to road.
- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
- 4 Stamped 2" Aluminum Cap on 5/8" x 34" long iron rebar. Placed large 2' boulder on N. side Set Blue Composite Post with loc. tag 1' South S49°W 29.33' to set N & T in NW side 17" R. Maple S10°E 19.53' to set N & T in W. side 8" Oak N33°E 13.59' to set N & T in E. side 10" Oak N24°W 12.47' to set N & T in W. side 8" Oak
- 9 Stamped 2" Aluminum Cap on 5/8" x 34" long iron rebar. Place large pointed stone on W. side. Set Blue Composite Post with loc. tag 1' NW S85°E 8.24' to Set N & T in N. side 5" Cherry S29°E 18.67' to set N & T in NE side 6" Cherry S45°W 15.59' to set N & T in NW side 9" Cherry West 15.19' to set N & T in N. side Apple in Clp. 4 S67°37'W 39.75' to found ½" iron pipe up 2.3'
