

- <u>J5</u> ¼ Corner common to Section 11 & 14, T23N, R5W Found ½" x 18" long smooth iron rod with unreadable cap 0.5' East of physical centerline N-S Bit. Road. Excavated under 1/2" iron but nothing else was found. Also dug a hole S19°W 2.2' away searching for evidence of corner based on doubling line and distance south from 'J4' through corner #12(CS 1/16). Dug down 3' but nothing was found at this location. Condition of witnesses as follows: #1, 2, 3, 4, 5, 7, 8, 9, and 10 are gone; #6 - Fd. Stump - 82.3' to Centerline.; #11 and 12 are OK. ½" CIR accepted as the best available evidence of the position of the original corner.
