B. DESCRIPTION OF CORNER EVIDENCE FOUND AND/OR METHOD APPLIED IN RESTORING OR REESTABLISHING CORNER:

Found ½" X 24" Rod and cap "Westshore #34972" at surface of bituminous road and found ½" X 18" Rod and cap #30389 below surface. The centerline of the gravel road going North and South is 3 feet West and in the centerline of gravel road going East and West. The condition of the recorded witnesses are: #1 thru #7 gone, #8 thru #10 good condition.

C. DESCRIPTION OF MONUMENT FOR CORNER AND ACCESSORIES ESTABLISHED TO PERPETUATE LOCATING THE POSITION OF THE CORNER:

Removed both Rod and caps and set a 4" diameter Harrison cast iron monument 20" long marked "County Surveyor" as a substantial marker for the section corner and is accepted as a careful and faithful reestablishment of the original corner.
