A. Description of original monument and accessories and/or subsequent restoration:

I found no record of subsequent restoration.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I found no remains of the original corner or accessories. There is a fence intersection and an iron pipe near the imescorner position but I did not accept them. I re-established the corner position by single proportionate measurement. This position falls 19.7' west and 17.7' north of a 5/8" iron pipe and 36.6' west and 17.3' north of an old fence intersection. I Monumented the single proportionate position as the best representation of the true 1/2 corner position.
