

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner.

No original evidence was found. The Norwich Road, which has been in existence since the early 1900's, runs North & South along the \frac{1}{4} line. At the calculated position of the corner I found a squared and painted wood post on the West side of the Norwich Road.

early 1900's, runs North & South along the $\frac{1}{4}$ line. At the calculated position of the corner I found a squared and painted wood post on the West side of the Norwich Road marked $\frac{1}{4}$. This had been installed by Champion Inc., timber cruisers. The latitude of the post was nearly on line with a recorded Section Corner $2\frac{1}{2}$ miles West. I used the squared wood post & the center-line of the Norwich Road as being the only logical position for the corner. I monumented the corner as described below.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner.

At the corner position I set a 5/8"X12" rebar with a 3" cap, 2" below top of blacktop. Cap is stamped to read: County Remonumentation, T48N R41W, S2, S11, $\frac{1}{4}$, 2000, P.S. 17610. I established three bearing trees and a reference monument, a $2\frac{1}{2}$ "X30" aluminum pipe with a 3" stamped cap.
