I, Matthew McClung in a field survey on 10-7, 19 96 do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

The original corner was set by deputy surveyor Sylvester Sibley on 7 July 1838. Set wood post 40.00 chains from South.

Pine 20" N72W 5 Lk.

Hemlock 10" S68E 35 Lk.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found 1 1/4" X 18" long iron pipe 1 foot East of centerline of North and South Road, in fence row to East 4" below road surface. Excavated to 14" and found 5/8" iron rod. Placed top of Osceola County Monument over cent of 5/8" iron rod 6" below road surface.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Corner G-8. Osceola County Monument, which is a 3" brass cap mounted on a 1" pipe 18" in length.
