B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I-4-W; Set monument on the section line common to sections 10 and 11 at a point 471.70 Ft. North of the $\frac{1}{4}$ corner common to sections 10 & 11 (I-4) as a witness monument to said $\frac{1}{4}$ corner which falls in Shamrock Lake. This monument is Approx. 50 feet north of the north shore of Shamrock Lake.

I-5-W; Set monument on the section line common to sections 14 and 15 at a point 1211.18 Ft. South of the section corner common to sections 10, 11, 14 & 15 (I-5) as a witness monument to said section corner which falls in Shamrock Lake. This monument is Approx. 45 feet South of the South Easterly Shore of Shamrock Lake.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

I-4-W; Set 1" pipe with Oscoda County brass cap.
