I, Joseph C. Domitrovich, in a field survey on November 5, 1999, do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

(M - 6/7 & A - 6/7) Meander Corner on the right bank of the Ontonagon River between Sections 13, T51N, R40W and 18, T51N, R39W.

1845 Austin Burt intersected the right bank of the Ontonagon River 20.60 chains (1359.60') North of the section corner and set a post with ties:

No Record of Subsequent Restoration.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I found no remains of the original Meander Corner or accessories. I found no evidence of any kind of the corner position. I therefore treated the corner as lost and re-established it by single proportionate measurement.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Corner is a 2 1/2" x 30" aluminum pipe with a 3" diameter aluminum cap stamped to read: County Remonumentation; T51N, R40W, R39W; M.C.; S. 13, S. 18; 1999; P.S. 37273. Corner falls 55' +/- North of present Right Bank of the Ontonagon River. Ties:
