Szyszkoski, in a field survey on 09/15/15 do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

A. Description of original monument and accessories and/or subsequent restoration:

(8-Sec. 33) Center-West 1/16 corner, Section 33. Not previously monumented.

(10-Sec. 33) South 1/16 corner between Sections 32 and 33. Not previously monumented.



B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(8-Sec. 33) Established the position for the corner midway and on a straight line between Quarter corner 1322.11' west and the Center of Section 33 1322.11' east.

(10-Sec. 33) Established the position for the corner midway and on the Section line between Section corner 1310.34' south and Quarter corner 1310.34' north.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(8) Set 1"IDx28" I.pipe with 2" alum. MDNR cap. Set measuring nail with MDNR tag in the side of: 4" Sugar N17°W 3.7' mrkd "1/16S BT" 6" Sugar N41°E 11.3' do 9" Sugar S29°E 17.65' do 7" Sugar S54°W 9.5' do Set sq'd cedar post adjacent. E= 7846611.318 N= 232643.631

(10) Set 1"IDx28" I.pipe with 2" alum. MDNR cap. Set measuring nail with MDNR tag in the side of: 13" Sugar N24°E 20.0' mrkd "1/16S BT" 6" Sugar S50°E 7.3' do 9" Sugar S02°E 10.35' do 6" Sugar N87°W 27.0' do Set sq'd cedar post adjacent. E= 7846205.159 N= 232249.558
