A. Description of original monument and accessories and/or subsequent restoration:

(8-Sec. 33) West 1/16 corner, Section 33. 1991 - Thomas P. O'Brien PS 21274 states in LCR L.2, P.324 that this corner was "set by section subdivsion". Set 1/2" I.B. 6" R.Pine N12E 73.9', Power Pole S60E 43.4'.

(3-Sec. 33) North 1/16 corner between Sections 32 and 33. Found no record of prior monumentation.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(8-Sec. 33) Found the 1991 monument in good condition and at record bearing and distance from the two 1991 witnesses. The monument does not occupy the proper position for the 1/16 corner, it being located N88 deg. 34'03"E 17.58' (MCS83 grid bearing) from a position midway and on a straight line between Quarter corner E12 and Center of Section F12. I did not accept the 1991 monument and established the corner midway and on a straight line between E12 and F12, 1338.63' west and east.

(3-Sec. 33) Established the corner midway and on the Section line between Section corner Ell 1309.52' north and Quarter corner E12 1309.52' south. The position for the corner falls in a wet cattail marsh.
