A. Description of original monument and accessories and/or subsequent restoration:

(G2) Quarter corner common to Sections 3 and 4. 1850 - Established by Guy Carleton Deputy Surveyor. Set post 40.12 ch. north of Section corner G3 and 39.72 ch. south of Section corner G1. Y.Pine 8" S46E 46 links, Y.Pine 18" S71W 53 links. 1960 - Reestablished by Billy D. Buckler RLS "midway between two Section Corners" [see below]. Set 1" pipe with 4" brass cap. 8" R.Pine N20E 19 links, 18" R.Pine N46W 86 links.

(13-Sec. 3) Southeast 1/16 corner, Section 3. Not established in the original survey.

- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- (G2) The original post and accessories were not recovered. Found the 1960 monument in good condition and at record bearing and distance from the 1960 witnesses, both in good condition. I note an error in the 1960 record: The monument was found at the proportionate position between Section corners (found 2646.82' south and 2618.30' north), not "midway and on line" as the record states. I accept the monument as a careful and faithful reestablishment of the position of the original corner.
- (13-Sec. 3) Established the corner at the intersection of straight lines connecting opposite 1/16 corners.
