**A. Description of original monument and accessories and/or subsequent restoration:**

(A9) Corner common to Sections 19-30 T47NR13W and 24-25 T47NR14W. Corner remonumented in 1956 by Billy D. Buckler, RLS, from two original 8fs. Corner monumented with a 1" pipe with 4" brass cap and the following: 20" W. Pine S87W 170 links, 18" R. Pine N36W 168 links.

(B7) Quarter corner common to Sections 18-19. Corner reestablished in 1959 by Billy D. Buckler, RLS, by proportionate measurement. Corner monumented with a 1" pipe with 4" brass cap and the following: 18" W. Pine stump N40W 59 links, 36" W. Pine stump S08E 94 links, 16" W. Pine stump N72E 49 links.

**B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:**

(A9) Found the 1956 monument, as described, in good condition, and at record bearing and distance from the 1956 witnesses, now both found as cut stumps. The 18" N36W has measuring notch showing. Left the monument in place and marked 4 new accessories as described below. Corner re-witnessed by T.Stark and D.Lampela, Newberry.

(B7) Found the 1959 monument as described, in good condition, and at record bearing and distance from the remaining 1959 witness 18" W. Pine stump N40W 59 links. The other two witness stumps have been destroyed. Left the monument in place and marked 4 new accessories as described below. Corner re-witnessed by T.Stark and D.Lampela, Newberry.

**C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:**

(A9) Found 1" pipe with 4" brass cap. Blazed, scribed, and set measuring nails in the following:

5" W. Pine S66E 26.45' "S30 NBT"  
30" W. Pine S69W 135.1' "S25 NBT"  
10" R. Pine N11W 29.05' "S24 NBT"  
8" R. Pine S34E 23.65' "S30 NBT"

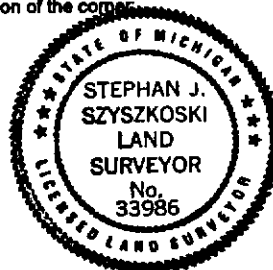
Placed a squared and scribed cedar post adjacent. Bearings are magnetic.

(B7) Found 1" pipe with 4" cap.

Blazed, scribed, and set measuring nails in the following:

12" W. Pine S29E 49.00' "1/4S NBT"  
11" W. Pine S08W 23.45' "1/4S NBT"  
9" W. Pine N34W 39.40' "1/4S NBT"  
6" W. Pine N69E 58.90' "1/4S NBT"

Placed location tag on blazed 12" W. Pine N83W approx. 133' from corner. Bearings are magnetic.
