, in a field survey on_ December 8 do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current menual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below:

A. Description of original monument and accessories and/or subsequent restoration: Line Common to P.C. 228 and P.C. 227

The line common to P.C. 228 and 227 was originally surveyed in 1810 (see research dossier for sketch and notes). Posts were originally set at the corners only and no line stakes are called out. Many subdivisions have been platted adjacent to this line, some delineating it with dimension, others not. The City of Detroit Survey Section has assembled and maintained their "Cartographical Maps" from record plat data and field work. These maps have been relied upon for a great number of years and are considered the best assembled collection of written evidence available. To the best of my knowledge, there has never been any subsequent restoration of this line, excepting the plats which were done long ago.

Description of corner evidence found and/or method applied in restoring or reestablishing corner: Line Common to P.C. 228 and P.C. 227

A complete analysis of this line from its southern beginnings at the Detroit River to its northern terminus just north of McGraw Avenue has been field measured by Spalding DeDecker & Associates, locating building lines, street lines, and alley lines at various positions (see research dossier). It is my conclusion that "two separate lines" of different bearing occur along this P.C. line with the change occurring at or near Grand River Avenue. Quite possibly, this may have occurred as the stages of early City development expanded outward. The specific points held as good and the relationship of the other various points field measured are labeled in the research dossier.

- Description of monument for corner and accessories established to perpetuate locating the position of the corner: Line Common to P.C. 228 and P.C. 227 -- See sketch on the back of this sheet.
- (C) Set 4"x 36" Concrete Monument w/Aluminum Disk stamped "WAYNE COUNTY REMONUMENTATION, SPALDING-DEDECKER, PS 38121" in a Monument Box Located approximately 35' North of the Centerline of Forest Ave. and approximately 222' West of the centerline line of 12th Street (Rosa Parks). The location of this property controlling monument is accepted as a careful and faithful determination of this private claim line based upon all known evidence


