- FOUND 1" IRON 1' WEST OF THE CENTERLINE OF MICHIGAN STREET AND IN CENTERLINE OF ALLEY TO EAST AS PLATTED AND 38' SOUTH OF WEST 30 ROAD CENTERLINE. DISTANCE FROM THE IRON TO THE SW CORNER (FOUND 1" PIPE) OF THE MAP OF THE VILLAGE OF HARRIETTE IS 1627.08' (1628.03'-PLAT) AND THE DISTANCE TO THE INTERSECTION OF MICHIGAN STREET AND GASTON AVENUE (FOUND 5/8" IRON) IS 187.86' (188'-PLAT) AND THE DISTANCE TO THE INTERSECTION OF MICHIGAN STREET AND PROSPECT AVENUE (FOUND 5/8" IRON) IS 955.48' (956'-PLAT). THIS CORNER IS ACCEPTED AS A THE BEST AVAILABLE EVIDENCE OF THE POSITION OF THE CORNER.
