A. Description of original monument and accessories and/or subsequent restoration:

Corner established by Austin Burt on 8/30/1847. Original B.T.s --- Y. Birch 18" S.32 W. 27 links (17.82') --- Y. Birch 30" N.82 E. 44 links (29.04') ---

Corner restored by Richard L. Drahn (21564) on 5/25/83, from the remains of the two original B.T.s. He set a 2" X 30" aluminum pipe with a 3/4" stamped aluminum cap and the following new B.T.s:

- 10" Sugar Maple N.28 W. 25.47'
- 7" Sugar Maple N.67 E. 50.32'
- 17" Hemlock S.10 E. 58.92'
- 6' Steel sign rail S.87 E. 2.4'

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Corner recorded in Gogebic County in Liber 2, Page 537 on 1/26/84.

Corner research on file with Gogebic County records.

Recovered the monument as described and the bearing trees as follows:

- 13" Sugar Maple N.30 W. 25.47' (new nail)
- 10" Sugar Maple N.66 E. 50.33' " "
- 20" Hemlock S.15 E. 58.92' " "
- 6' Steel sign rail S.89 E. 2.36'

Badly decayed Yellow Birch stumps still remain from the original B.T.s.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

New bearing tree referenced:

- 11" Sugar Maple S.75 W. 17.18'
