Fd. old fence corner for fences E, W & N. Dug for evidence of sleigh shoe iron & GLO BT's at & around fence corner but found nothing.—Fd. 22" W. Pine Stp. remains for apparent GLO BT and set 4" DOC (DNR) alum. Cap on 1" x 4' galv. Iron pipe at record GLO bearing and distance from BT. This position is 2 foot South of a split with the overall grid distance of 5277.57' vs. 5280' — GLO for the overall mile. Corner position is 1.24 feet West of straight line from K3 to K5. Dug at SE BT's position and found some burnt pine wood. 22" WPS is only visible pine stp. in area which is low and damp. Corner of newer fences N & W is 29.5' ± S & 14' E. Corner of old fences we dug at is 13'+N & 5'+E.Also dug for 16" W. Pine line tree 169.6' south.
