A. Description of original monument and accessories and/or subsequent restoration:

A11 - M11 - corner common to sections 30 & 31, T20N, R5E and sections 25 & 36, T20N, R4E

- 2002 Remon LCRC - L. 2, P.314 - Craig W. McVean, PS #39088 - Fd. 1" x 1' long tapered round bar w/ threads with 2" x 2" x 6" wood stake on N. side & 3" x 3" x 12" cedar stake w/ axed pt. on S. side - down 1'. Dug down 2' and also find old plow point below. All of MDOT's BT's are gone but this agrees with MDOT's description of corner monument. CL of N-S Gravel Rd. is 1'± W. CL of Gravel Rd. W is 9' N. On CL of Gravel Rd. E extended W'ly. 1" iron bar per MDOT accepted as the best available evidence of the position of the original corner.

Reference Pt. 'A' – Fd. R.R. Spike N8°51'W 5.90' of "A11-M11" per Miller's Rec. Survey L. 1, P. 491 Witnesses. Excavated position but no other evidence to support position was found. RR Spike used by Miller not utilized as "A11-M11" in this survey – removed. Reference Pt. 'B' – Fd. 2nd R.R. Spike N6°12'E 4.60' of "A11-M11" that fits Miller's Rec. Sur. L. 2, P. 137 based on his record distance to K11. Excavated location but no other evidence to support position was found. 2nd R.R. Spike not utilized as "A11-M11" in this survey – removed.

- Replaced 1" x 1' iron rod w/ 3" Arenac Co. Remon. Brass Cap on 5/8" x 34" Rebar w/ 4" x 1' long PVC filled w/ conc. around cap Down 0.5'. Placed 2 Fd. stakes & plow pt. at base of monument as memorials. S60°E 57.05' to set N & T in NE side 3" Fir; S72°W 61.13' to set N & T in N side 22" B. Oak (RLM); N45°W 59.57' to Fd. N & Tag #15397 in NW side UP (RLM); N36°E 86.88' to set N & T in NW side 7" B. Oak
- B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

A11 - M11 - corner common to sections 30 & 31, T20N, R5E and sections 25 & 36, T20N, R4E

Found 5/8" rebar in broken concrete & PVC at road surface and the 2002 accessories fitting position. Drove rebar down and placed broken concrete around it. Added 3" stamped brass cap to rebar. Brass cap is 0.6' below grade. 3" stamped brass cap on 5/8" rebar is accepted as the best available evidence of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

A11 - M11 - 3" stamped brass cap on 5/8" rebar.
