Sugar 12" S16E 27 links, Sugar 14" N40W 28 links. 1988 - Remonumented by K.L.Sackett RLS: "Original monument and accessories not found. Found 4" squared post, signature tree and location poster. Restored [corner] at old post. Fits good with land calls and has been used for many years". Mr. Sackett set a 1"IDx36" I.pipe with 4" aluminum cap at the corner position.
