I, Stephan J. Szyszkoski, in a field survey on 11/26/12 do hereby state
that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2
above were in conformance with regulations and rules therefore as required in the current manual of survey
Instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of
a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with
the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established,
re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded
on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

(F9) **Quarter corner common to Sections 21 and 28.** 1853 - Established by Francis Coleman Deputy Surveyor
midway and on the Section line between Section corners 40.22 chains East and West. Set post. Y.Pine
20" N32E 19 links, S.Pine 12" S55W 22 links. 1958 - Remonumented by Billy D. Buckler RLS at record
bearing and distance from probable B.T. Y.Pine bearing N32E 19 links, stump burned badly. Set 1"ID
I.pipe with 4" brass cap. 13" R.Pine N65W 86 links, 12" R.Pine N48E 88 links. 1975 - K.L.Sackett RLS
used the corner to subdivide Section 28, but took no additional witnesses.

(E9) **Corner common to Sections 20-21-28-29.** 1958 - Billy D. Buckler RLS remonumented the corner from
numerous blazes in vicinity and swamp edge 50 links to west. Found Jack Pine bearing S46E 35 links
scribed "R34WT49N", marked many years ago. Set 1" pipe with 4" brass cap. 8" J.Pine N39W 43 links, 6"
J.Pine S34W 47 links.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(F9) The 1958 monument and accessories were not recovered and appear to have been destroyed. No direct
evidence of the corner position was found on the ground. Reestablished the 1958 position using the
field notes of the 1975 subdivision by K.L.Sackett, at Mr. Sackett's distance, indexed, north of F10
and on a prolongation of a straight line from F11 through F10.

(E9) Found the 1958 monument in good condition and at record bearing and distance from the 1958 NBT
J.Pine N39W 43 links, now a dead, leaning stub. The other 1958 NBT is gone. Accepted the monument as
the best available evidence of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(F9) Set 1"IDx32" I.pipe with 4" alum. MDNR cap.
Set 4"x4" cedar post N07°E 0.8'.
The corner position falls in a plowed field and no
other accessories are available.
MCS83 bearing and grid distances to:
G9 = S88°07'51"E 2634.87' (2635.24' ground)
E9 = N88°29'21"W 2644.30' (2644.67' ground)
E=7880238.381 N=205526.796

(E9) Found 1"ID I.pipe with 4" brass MI Dept. of
Conservation cap. Set measuring nail with MDNR
tag in the side of:
12" J.Pine N48°E 3.25' mrkd "S21 NBT"
6" W.Birch S37°E 23.65' "S28 NBT"
4" R.Pine S75°W 13.15' "S29 NBT"
6" Maple N50°W 25.55' "S20 NBT"
Set sq'd Cedar post adjacent.
E=7879432.679 N=205548.046
