- a.) Quarter corner common to Sections 14 and 23. 1852 Established by Z.B.Searles, Deputy, midway and on the Section line between Section corners 40.00 chains east and west. Set post. Hemlock 12" S66°E 11 links, Maple 14" N32°W 22 links. 1947 Norman T. Thompson RLS recovered the original BTs (noted as "OK") and set a Cedar post at the corner position. No other witnesses.
- b.) Quarter corner common to Sections 13 and 14. 1852 Established by Z.B.Searles, Deputy, midway and on the Section line between Section corners 40.00 chains north and south. Set post. Sugar 8" S35°E 30 links, Sugar 8" N73°W 14 links. 1943 Norman T. Thompson RLS notes: "OBT Sugar 8" S35°E 19.8' OK no scribing. Set Heml post. New BT Sugar 14" S59°E 18.5', New BT Sugar 12" S29°W 23.6'".

Part B: Surveyor's Report on Perpetuation, Restoration, Reestablishment, or Monumentation of Corner

- a.) Sept. 25, 2017. Found a 1"ID iron pipe at record bearing and distance from the rotting stump remains of the original OBT Hemlock 12" S66°E 11 links, no markings visible. Two Celotex Corp. location posters on nearby trees face the pipe and indicate that it marks the corner position. No evidence of the Maple OBT. Accepted the pipe as a careful and faithful perpetuation of the position of the original corner and placed a yellow plastic cap "Mich DNR PS33986" in the top of it.
- b.) Sept. 26, 2017. Found no evidence of the original corner nor the 1943 witnesses. Found a 1" ID pinched pipe with an 11" dia. Y.Birch, blazed 4-sides with overgrowth 4" thick, adjacent to the pipe. A Ford Motor Co. location poster on a 5" Sugar faces the pipe, 1.7' distant, and is marked to indicate the corner. The poster looks older than the Sugar, perhaps having been moved from some other tree to its present location. Distance from the pipe to corner KO7 was found to be 2630.93' and the bearing of that line differs from the GLO record by less than 9 minutes of arc. I accept the pipe as the best available evidence of the position of the original corner.
