(11-Sec. 4) Southwest 1/16 corner of Section 4, being the SE corner of Government Lot 2 and the NE corner of Government Lot 3. The corner is shown as monumented with a 3/4" capped pipe set by S.C.Hein PS on a 1992 survey recorded in Liber 1 of Surveys, Page 214.
