Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

J5 - ¼ corner common to sections 11 & 14, T25N, R14W- Based on the Pettitt survey dug a 4' ± diameter area and find an apparent stake shadow within 2' of the calculated proportional Pettitt position. The Shadow being a 2 to 3" diameter vertical vein of white sand into brown sand, the bottom being 2' + below the ground surface. Accepted the stake shadow as a careful and faithful perpetuation of the position of the original corner per the Pettitt survey.

PCC near J5 - Found 1/2" capped iron rebar #28417 per LCRC by Geisert is N65°21'E 38.52' from 'J5'. This ½" CIR was set without regard to the Pettitt survey. The Pettitt survey was apparently missed in this area by Geisert in his research when he was with Mitchell and Associates. I provided Mitchell and Associates copy for their file. Its single proportion position does not agree with the Pettitt survey and is not utilized as 'J5' in this survey. This property controlling corner is recorded by this surveyor strictly to comply with the requirements of P.A. 74 of 1970 as amended and P.A. 345 of 1990 as amended and is not an endorsement of the corner position.
