B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

E-13 - Standard Corner common to Sec.'s 32&33, T27N,R13W - FND. 3/4"x 1.15' long Rebar, down 2" - Remove and find cross Iron, 0.2'x 0.2' by 1.8' long, down 1.3' and being 0.01' W & 0.05' S of top Iron. Accept bottom ' + ' Iron as corner monument. Monument in line w/ gravel Rd. N & 3'± N of E-W gravel Rd. CL. Fits GLO distance to E-1, T26N,R13W to the East. ' + ' Iron accepted as the best available evidence of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

E-13 - Replaced ' + ' Iron & Rebar w/ 3" Benzie Co. Brass Cap on 3/4" Pipe encased w/ 4"x 36" Conc. Cylinder w/ small ring of cobble stones - down 0.5'
