



A. Description of original monument and accessories and/or subsequent restoration:



## I-5 Corner Common to Sections 10, 11, 14 & 15, T44N, R1W.

1845 - Original corner established by James H. Mullett. Witnesses: Hemlock 20, S65°E 15 links - Hemlock 16, N35°W 27 links.

1918 - Chippewa County Surveyor Frederick H. Brown, RLS 944. Brown's notes for Section 14 indicate that this is probably "Stillwell's" corner, at intersection of roads north and east.

1925 - Chippewa County Surveyor corner tie book. Brown & Colwell reference a 15" concrete monument.

1946 - Chippewa County Surveyor Rudolph H. Larsen, RLS 3644. Notes show a post at road intersection.

1962 – Billy D. Buckler, RLS 8887, Michigan Department of Conservation Land Corner Record, Liber 3, page 139, Chippewa County corner records. Corner placed in road intersection, agrees with records of fences to east.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

E VUMENT This corner is being perpetuated as part of the Chippewa County Remonumentation Program. Found a 1" pipe with a brass Department of Conservation cap and established new witness objects. The distance to the section corner on the meridian at M-7 two miles to the east is within 1.8 feet of that as shown in the above mentioned County Surveyor notes by Frederick H. Brown.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Found a 1" pipe with a brass Department of Conservation cap at the corner location, which falls at the approximate centerline P.I. of roads to the east and north.
