

A. Description of original monument and accessories and/or subsequent restoration:

I-11 Corner Common to Sections 26, 27, 34 & 35, T44N, R1W.

1845 - Original corner established by James H. Mullett.

Witnesses: Tamarack 20, N72°E 19 links - Tamarack 10, S60°W 34 links.

1896 - Chippewa County Surveyor Frederick H. Brown, RLS 944. Notes indicate that this corner was made by "Kenworthy" for the Township.

1925 - Chippewa County Surveyor corner tie book. Notes by Brown & Colwell indicate a 15" concrete monument.

1966 - Chippewa County Road Commission Section Corner Record, as recorded in Liber 3, page 169, Chippewa County corner records. Found cedar post at "Lester Hancock Corner." Witnesses: REA Pole, 44.10' NW - Iron Corner Fence Post, 27.0' NE - G.T.P., 40.0' SE.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

ENONUMENT OF STREET This corner is being perpetuated as part of the Chippewa County Remonumentation Program. Found a %" square iron in the intersection of Hancock Road & 23 Mile Road. A considerable amount of fill has been placed on the roads in this area, the found iron is now approximately 2.5 feet below the gravel surface. Placed a %" rebar with a plastic Chippewa County Remonumentation cap over the found iron and established new witness objects.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Placed a ¾" x 24" rebar with a plastic Chippewa County Remonumentation cap at the corner location, over a ,found ¾" square iron, at the intersection of gravel roads east, west, north, and south. (23 Mile Road & Hancock Road). Witnesses:
