

1905 - Chippewa County Surveyor Frederick H. Brown, RLS 944, notes indicate an original corner here, being the only original corner in this vicinity. A large cedar post and monument.

Circa 1930's - Chippewa County Surveyor corner tie book shows this corner with several witnesses.

1991 - LCRC, liber 7, page 333, Chippewa County corner records. Keith R. Waters, P.S. 33142, found 3/4" iron bar.
