

A. Description of original monument and accessories and/or subsequent restoration:

(E-3) Corner Common to Sections 4, 5, 8 and 9, T.45 N., R.1 E.

Original corner post was placed in September, 1845 by James H. Mullett. County Surveyor "Corner Ties" book indicates a cement monument and gas pipe. In September, 1990 Ronald Bischer, P.S. 22428, found 1" gas pipe and filed L.C.R.C. in Liber 7, Page 246 of the Chippewa County Corner Records. Pipe has also been used in surveys by Lawrence E. B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(E-3) Corner Common to Sections 4, 5, 8 and 9, T45 N., R.1 E. This corner is being re-established as part of the Chippewa County Remonumentation Program,

Found 1" iron pipe 18" below grade in Westerly edge of gravel driveway to South, on extension of centerline of Shunk Road to North and on extension of North edge of Thirteen Mile Road to West. Found no evidence of concrete monument. Accepted corner position as found and established new witnesses.
