I, William L. Karr, in a field survey on November 13, 1996, do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law, established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

(M-7 / M-8) Meander Corner Common to Section 24, T. 46 N., R. 1 E., and Section 19, T. 46 N., R. 2 E.

1845 J.H. Mullett set post in original survey, 10 chains North of the 1/4 corner.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(M-7 / M-8) Meander Corner Common to Section 24, T. 46 N., R. 1 E., and Section 19, T. 46 N., R. 2 E.

This corner is being reestablished as part of the Chippewa County Remonumentation Program.

Could find no evidence of the original corner or subsequent restoration.

Reestablished the corner on the extension of the section line to the South at the record GLO distance North from the 1/4 corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(M-7 / M-8) Meander Corner Common to Section 24, T. 46 N., R. 1 E., and Section 19, T. 46 N., R. 2 E.

Corner is a 3/4" x 48" re-rod with stamped aluminum Chippewa County Remonumentation Cap. Corner is set in open marshy area and is 1' above ground.

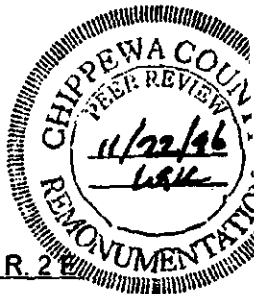
