

I, William L. Karr, in a field survey on December 7, 1999, do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and for that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.



A. Description of original monument and accessories and/or subsequent restoration:

(K-2 / K-3) Meander Corner Between Sections 1 and 2, T, 47 N., R. 1 W.

1845 James H. Mullett set post for corner in original survey, 5.00 chs North of section comer.

1854 Thomas Whelpley, U.S. Survey of Private Claim No. 1, Sault Ste. Marie. Field notes show Whelpley recovered the original section and meander corners and measured 4.60 chs between them.

101 F.H. Brown, Plan of Bradley Watkins and Co. Mill and Docks in County Surveyors office, plat book #1. The

drawing shows the North and East lines of fractional section 2, the position of the meander corner being in the water 303.6' North of the section corner.

1912 F.H Brown, additional survey work for Bradley Watkins Company. Drawings in County Surveyors office show no indication of the meander corner being monumented.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(K-2 / K-3) Meander Corner Between Sections 1 and 2, T, 47 N., R. 1 W. This corner is being perpetuated as part of the Chippewa County Remonumentation Program.

Could find no evidence of the original corner or of subsequent restoration. Brown appears to have used Whelpley's distance for his surveys (4.60 chs), however at the time of his surveys the meander corner appears to fall in the water. Presently the area around the meander corner has been filled in to form a large peninsula which extends several hundred feet beyond the original shoreline forming the former Reiss Coal Docks.

Re-established the meander corner by extending the section line from the South the original G.L.O. distance, 330.00' (5.00 chs) North from the section corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(K-2 / K-3) Meander Corner Between Sections 1 and 2, T, 47 N., R. 1 W.

Corner is a 3/4" x 24" iron with a stamped aluminum Chippewa County Remonumentation cap.
