I, Mark L. VanRaemdonck, in a field survey on, June 10, 1999, do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below:

A. Description of original monument and accessories and/or subsequent restoration:

1. Original, not a G.L.O. corner. No record was found of the original corner position.
2. Larry A. Bryan, L.C.R.C., recorded Liber 2, page 553, March 18, 1995.  
Monument: Found 1/2" bar 3.5' West of centerline Airport Road on fence line East.  
Accessories: Set Nail & Tag North side corner post S80°W 33.75'  
Set Nail & Tag South side power pole East 48.23'  
Set Nail & Cap West side 16" Ash S35°W 150.80'  
1/2" bar & cap East 1/4 corner, Section 1, T5N-R3W South 12.10'

Monument: Found 1/2" bar 3.7' West of centerline Airport Road on fence line East.

B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

I established this corner position on the line between corners M-2, T5N-R3W, and M-1, T5N-R3W at proportion distances to G.L.O. distances between corners A-1, T5N-R2W and A-3, T5N-R2W. A-1 to A-2, G.L.O. = 39.37 chains (2598.42 feet) measured 2596.12 feet. A-3 to A-2, G.L.O. = 40 chains (2640.00 feet) measured 2637.74 feet. This location is 2.73 feet East of the 1/2" bar referenced in No. 2 and No. 3 above. Found no other conflicting evidence. I accepted this location as the careful and faithful establishment of the original corner position.

C. Description of monument for corner and accessories to perpetuate locating the position of the corner:

Set a standard Clinton County Remonumentation monument, being a 2 1/2" diameter steel tube, 30" long with a standard brass cap, stamped "P.S. 24622", and a breakaway magnetic base at the corner location described in Section B above. The monument is witnessed by the following accessories:

East 45.30' Set N&T N. face util. Pole  
S50°E 58.61' Fnd. N&T SW face 12" Pine  
S40°W 57.70' Fnd. N&T SE face 8" Black Ash  
S75°W 43.52' Set N&T S. face 8" Oak  
N00°16'43"E 2596.18' Remon Monument at A-1  
S00°16'43"W 11.63' Remon Monument at M-2

Bearings to A-1 and M-2 are based on solar observations.
