M.S. McNABB - 1920 - FOUND IN PLACE A WOOD POST DURING A ROAD ALIGNMENT SURVEY FOR COUNTY ROAD 414. "DROVE I.P. IN STAKE" - NO WIT'S
NOTED.

I-6 [W1/4 COR S.14] GEORGE ADAIR, D.S. - 1852 - WOOD POST (Y.BIRCH 16"-N20°W-32 LINKS) (CEDAR 10"-S20°E-20 LINKS)

D.A. BROTHERTON - 1896 - IDENTIFIED FROM ORIGINALS - NO NEW WIT'S NOTED - SET IRON STAKE

M. DAVIS, RLS - 1974 - FOUND IRON BOLT IN PLACE - IDENTIFIED FROM LINES OF OCCUPATION - NO EVIDENCE OF "GLO BT'S" - REPLACED IRON
BOLT W/A 4" X 4" X 36" CONC MON. W/A BRASS CAP STAMPED TO ID THE CORNER POSITION & REC'D. SAME IN LIBER 2 OF LCR'S ON PAGE 76.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I-5 [NW COR S.14] FOUND IN PLACE, AT PI OF COUNTY ROAD C/L N & W A 3/4" IRON PIPE SET IN THE
REMAINS OF A WOOD POST. DISTANCES TO ADJOINING CORNERS CK WELL WITH "GLO" AND OTHER REC'D.
DISTANCES. ACCEPTED EXISTING MONUMENT AS BEING THE BEST AVAILABLE EVIDENCE AS TO THE LOCATION
OF THE POSITION OF THE ORIGINAL CORNER.

I-6 [W1/4 COR S.14] FOUND IN PLACE THIS DATE A CONC MONUMENT W/A BRASS CAP STAMPED TO ID THE
CORNER POSITION. IDENTIFIED THE SAME AS BEING THE MONUMENT I SET IN 1974 FROM THE REMAINS OF
BOTH BT'S AS ESTABLISHED IN 1974. ACCEPTED EXISTING MONUMENT AS BEING A CAREFUL & FAITHFUL
PERPETUATION OF THE POSITION OF THE ORIGINAL CORNER.
