A. Description of original monument and accessories and/or subsequent restoration:

- Volume 1, Page 53 of Eaton County Surveyors' records show a survey by J.H. Gibbons C.S. in April 1869 in 4. which the corner was described as a stone and crockery, measuring 40.35 chains (2663.10') form L-8. Witness: Hickory 8" S 32 1/2° E 43 1/2.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found a 3/4" pipe in bad condition in a monument box in the centerline of Bellevue Road and on agricultural field occupation North. Found witnesses: Base of angle iron in concrete N 25° W 38.55'; Nail and Tag #12034 South side Utility Pole N 75° E 98.76'; Nail and Tag #12034 South side Utility Pole N 80° W 166.42'. Excavated a 2' x 2' area around the 3/4" pipe. Encountered original clay road bed ±2.5' below asphalt surface. Dug ±.5' into clay. Found no evidence of prior monumentation. Accepted the 3/4" pipe as the perpetuated location of the corner. Set a 3/4" x 24" iron form pin with a 2 ½" diameter aluminum P.A. 345 cap #28414 in place of the 3/4" pipe.
