

I, Anthony Bumstead, in a field survey on March 17, 2000 do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

- A. Description of original monument and accessories and/or subsequent restoration:

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Searched at apparent location of corner and found Accolade bar & cap 0.4' below surface ±2.5' South of C/L power lines at North-South field division. Helsel set corner at intersection of 1/4 lines. Subsequent remonumetation of the four 1/4 corners shows that Helsel used the accepted 1/4 corners. Therefor, accepted Helsel's location as the perpetuation of D-12 and set standard remonumentation bar and cap. Bryan measured West to C-12 a distance of 2648.93', Bryan measured South to D-13 a distance of 2649.85' and Helsel measured same line 2650.09', Burnstead measured North to D-11 a distance of 2642.98'.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Set 3/4"x24" Bar and PA 345 Disk #41095 as noted above Found nail & tag #25832 North side utility pole, West, 148.18' Found nail & tag #25832 East side 12" Cottonwood, S15°W, 172.61' Found nail & tag #25832 East side 12" Cottonwood, S18°W, 184.74' Found Accolade nail & tag Southwest corner creek abutment, East, 71.81' Found Accolade nail & tag 8" dead Elm, Found nail & tag #25832 South side utility pole, East, 313.37'


