SEARCHED AT APPARENT LOCATION OF CORNER AND FOUND 1/2" BAR AND CAP #18988(D. FLUKE) 5.5' SOUTH AND 3' WEST OF CENTERLINE INTERSECTION VERMONTVILLE HIGHWAY AND SHAYTOWN ROAD. TRAVERSED TO FLUKE'S IRON FROM 1/4 CORNERS IN ALL FOUR DIRECTIONS AND TO NAIL AND TAG AT 1/8TH CORNER TO THE WEST THAT D. FLUKE SET FROM EXISTING 1920 WITNESSES. CORNER IS ON LINE WITH 1/4 CORNER AND 1/8TH CORNER TO THE WEST AND IS SAME DISTANCE EAST OF 1/8TH CORNER AS 1/8TH CORNER IS EAST OF 1/4 CORNER. STRAIGHT GLO PRORATION IN EAST-WEST DIRECTION AGREES WITH POSITION OF CORNER EXACTLY. LOCATION OF CORNER HAS BEEN CUT AND FILLED AT LEAST THREE TIMES SINCE 1919.
