

  - 3. County Survey Records by Morrell E. Newcomb, County Surveyor, dated 1907 (Volume 5 Page 30) calls for same witnesses as #2 above. (continued on back)
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found 3/4" pipe in monument box  $\pm 1$ ! South of centerline of Mt. Hope Highway & on centerline of Nixon Road as called for by Steadman in #11 above. Remaining witnesses listed above checked with location of 3/4" pipe. Held pipe as perpetuated location of C-9.

- 4. Sec. Cor. 19-20-29-30, Gas pipe noted, in 1917 by H.A. Williams in a marginal note of the Eaton County Road Commission copy of the Original Government Survey notes. Witnesses shown as: Anc. Post N45°E 47', NW Cor. School S51 1/2°E 123', Anc. Post S41 1/2°W 42'.
- 5. Steadman, P.S. #11370, survey recorded in Liber 1 of Surveys, Page 968, dated 7-2-75 calls for "Found 1" iron pipe; raised with 3/4" iron pipe in mon. box" with witnesses: P.Pole N41°W 49.60', T.Pole N66°W 77.43', P.Pole S46°W 40.86', T.Pole S40°E 41.85'.
- 6. Steadman survey recorded in Liber 1 of Surveys, Page 973, dated July 7, 1975 calls for same monument & witnesses as #3 above, excepting the T.Pole N66°W 77.43'.
- 7. Steadman survey recorded in Liber 2 of Surveys, Page 82, dated 6-7-76 calls for same monument & witnesses as #6 above.
- 8. White, P.S. #12034, survey recorded in Liber 2 of Surveys, Page 162, dated August 20, 1976 calls for same monument & witnesses as #6 above.
- 9. L.C.R.C. recorded by Fred N. White in Liber 2 of Corners, Page 361, dated 8-24-76 calls for same monument & witnesses as #6 above.
- 10. Steadman survey recorded in Liber 3 of Surveys, Page 245, dated Aug. 11, 1980 calls for same monument & witnesses as #6 above, except change of T.Pole S43°E 42.68'.
- 11. L.C.R.C. recorded by Richard W. Steadman in Liber 2 of Corners, Page 739, dated October 15, 1981 with field work done on June 2, 1975, calls for same monument & witnesses as #5 above, except change of T.Pole S43°E 42.68'. Steadman notes in #11 above that he found 1" gas pipe 15" below surface & further digging yielded nothing, & remains of old anchor post were found S.W. 43' as called for in #2 & #4 above, but schoolhouse was gone.
