A. Description of original monument and accessories and/or subsequent restoration:

1823, GLO notes, John Mullet, D.S., set wood post and two accessories

1872, County Surveyors Records, No description of monument given, L-5, K-5 2751.3'

1920 GCRC dwg #1195, no description of monument given, L-5, K-5 2751.3'; L-5, M-5 2751.1'

1971, Act 74, A.F. Miller, #12024, L.1838, P.452, 3/4" Iron Pipe, two accessories, L-5, K-5 2752.18'

1972, Act 132, Carl H. Carlson, #9189, L.1838, P.452, Fnd, iron, 3 accessories, found one, N15E, 39.50' 5" Tree (R), 39.36'(M)

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

1999 REMON - Found ¾" pipe in monument box.

In 1823, D.S. John Mullet Indicates setting a wood post at corner L-5. Two measurements are indicated L-5 to K-5 41.54 chains (2741.64 feet); L-5 to M-5, 41.54 chains (2741.64 feet). Two accessories are also noted, neither of which exist in 1999. In 1872, Genesee County Surveyor records (small book narrative record page 222) no description of corner L-5 is given. One measurement, L-5 to L-6, 40.10 chains (2646.6 feet). In 1920, GCRC records, drawing no. 1195 indicates two measurements L-5 to K-5, 2751.3 feet; L-5 to M-5, 2751.1 feet. No description of the monumentation for corner L-5 is given. In 1971, A. F. Miller P.S. #12024 in a recorded Act 74 form, Liber 1838, Page 139 indicates a ¾" pipe as the object in place for corner L-5. Two accessories are noted, one of which exists in 1999 north 50.03 feet to concrete monument; today in 1999 I measure north 50.05 feet to this concrete monument. One measurement, L-5 to K-5 2752.18 feet. In 1972, Carl H. Carlson, P.S. #9189 in a recorded Act 132 survey indicates a found iron as the object in place for corner L-5. Three accessories are noted, one of which exists in 1999, N15°E, 39.50 feet, 5" tree; 1999, N15°E, 39.50 feet, 5" tree; 1999, N15°E, 39.36 feet, within 0.14 feet of record. In 1973, a sketch by FSE indicates two measurements, L-5 to K-5, 2751.99 feet; L-5 to M-5, 2751.59 feet, no description of corner L-5 is given. In a 1978 Rowe witness card, four accessories are noted, all of which are gone in 1999. In a 1990 Rowe witness card, a found %" rod and %" pipe in monument box are noted along with four accessories, all of which exist in 1999 and compare within 0.03 to 0.04 of record. (Cont'd on back)

Undated sketch from FSE, no description of monument given, L-5, K-5 2752.03' (R) 2752.17(M); L-5, M-5 2752.41' 1999, Act 132 Joseph Wizynajtys, #21585, 3/4" pipe in mon. box, 5 accessories noted, all check well.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner (Continued):

In 1996, Glen A. Fauser, P.S. #18557, in an Act 132 survey recorded in Liber 3488, Page 314, indicates finding a ¾" pipe, no mention of the monument box is made. Two accessories are noted, one of which exists in 1999 north 50.03 feet to concrete monument. In 1999, I measure north 50.05 feet to this same concrete monument. Again in 1997, Glen A. Fauser, P.S. #18557 in an Act 132 survey recorded in Liber 3497, Page 533, indicates a ¾" iron pipe, no mention again of the monument box. Two accessories the same concrete monument as in the 1996 Fauser survey being found in 1999. Three measurements L-5 to L-4, 2640.85 feet; L-5 to L-3, 5280.28 feet; L-5 to M-5, 2752.34 feet; in a sketch by FSE. Two measurements are indicated, L-5 to K-5, 2752.03 feet; L-5 to M-5, 2752.41 feet. No description of the object in place for corner L-5 is given. In 1999, Joseph Wizynajtys, P.S. #21585 in a unrecorded Act 132 survey indicates a found ¾" pipe in monument box for corner L-5. Apparently the ¾" rod found in 1990 by Rowe is gone. Five accessories are noted, all five of which still exist and compare within 0.02 feet to 0.06 feet of record. The concrete monument which was first mentioned in the 1971 survey still in existence on the Wyznajtys survey.

In the 1999 remonumentation program I am finding a ¾" pipe in a monument box. I excavated to a depth of three plus feet below the ¾" pipe and found no further monumentation for corner L-5. The position of the ¾" pipe in monument box fits a tree line running to the north and to the south. Based upon the consistency of measure between corners L-5 to K-5 and L-5 to M-5 over the period of years from 1920 to present and the description of L-5 as a ¾" pipe from 1971 to present along with the distance to the concrete monument, I accept the position of the ¾" pipe in monument box as the best available evidence of the original corner.
