

Corner positioned 0.85 chains N.74 W. from Mile Corner $#6\frac{1}{2}$.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Restored corner position at record bearing and distance from the remains of the two original bearing trees. The first is a 24-30" Yellow Birch stump decayed to ground line. The second one is now a very large wind-thrown stump hole. The 0.85 chain distance SE along the State Line is in accordance with the field notes of the original survey to Mile Corner #6½.
