I, Richard L. Drahn in a field survey on October 2, 19 97, do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below:

A. Description of original monument and accessories and/or subsequent restoration:

Corner established by John Burt on August 31, 1847. Original B.T.s --- Hemlock 22" N.49 E. 40 links (26.40') --- Y. Birch 18" N.49 W. 25 links (16.50') ---

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Restored corner position at record distance from Mile Corner No.  $\frac{1}{2}$  and record bearing and distance from the decayed remains of the two original bearing trees. The first is a series of root holes with fragments of Hemlock wood and bark. The second one is now a series of root holes with decayed fragments of Yellow Birch bark and wood.

At the corner position I set a 2" X 30" aluminum pipe with a 3 $\frac{1}{4}$ " aluminum cap stamped to indicate the corner position and the following new B.T.s:
